Receive various county reports, news and information.


The EOC updated regarding a disturbance in the Gulf. Judge Sklar reminded Court of the July Budget hearings.

A motion was made by Comm. Bubela, seconded by Comm. Hunt to adjourn at 9:15 a.m. Meeting **ADJOURNED.**


