**SCHEDULE OF ACCEPTABLE FINES
LICENSE AND WEIGHT**

- 1. This letter is furnished as a courtesy to you by the Justice Courts of Jackson County, Texas to assist you in making disposition of the charge or charges filed against you. Certain charges can be dismissed by complying with the state's requirements. The court clerk can answer questions about your citation after the ticket is filed in our office, but you must inquire before your appearance date.
- 2. IF YOU WISH TO ENTER A PLEA OF GUILTY OR NOLO CONTENDERE , please so indicate in the proper space provided below. A plea of Nolo Contendere means that you do not contest the state's charges against you. Either plea will result in a finding of guilty and indicates that you agree to waive appearance for trial. A plea of Guilty may be used against you in a civil suit for damages, but a plea of Nolo Contendere cannot.
- 3. You should refer to the schedule shown on the reverse side of this letter to determine the amount of your fine(s). Send payment by Cashier's Check or Money Order (Company Checks accepted) payable to the Judge circled above, or pay by Credit Card.
- 4. IF YOU WISH TO ENTER A PLEA OF NOT GUILTY and desire a trial, you must so indicate in the proper space provided below. You shall be notified by mail of the court date set for your hearing. You have the right to trial by jury, if you so request. You also have the right to be represented by an Attorney, however, there is no right to a court appointed attorney in these Class C misdemeanors.
- 5. IF YOU FAIL TO RESPOND TO THIS CHARGE BY THE APPEARANCE DATE SHOWN ON THE CITATION, AN ADDITIONAL CHARGE MAY BE FILED AGAINST YOU FOR FAILURE TO APPEAR AND A WARRANT MAY BE ISSUED FOR YOUR ARREST, WHICH WILL RESULT IN ADDITIONAL FEES.
- 6. If additional information is needed, call the number above. IT IS YOUR RESPONSIBILITY TO CONTACT THE COURT NOT THE COURT'S RESPONSIBILITY TO CONTACT YOU. You must provide the Court with your current physical address and mailing address.
