At which time the following proceedings were had:

Invocation and Pledge

Comm. Hunt opened the meeting with prayer and Judge Sklar led the reciting of the Pledge of Allegiance of the United States of America.

Citizens Comments-Opportunity for the public to address Commissioners' Court on non-agenda items. The Court may not comment nor deliberate on non-agenda items. (Presentations should be limited to (5) minutes)

There were none.

Approval of Minutes and/or additions and corrections, if any.

The minutes from February 11, 2020 were submitted.

A motion was made by Comm. Belicek, seconded by Comm. Bubela, to approve the minutes. Motion carried.

Consider budget amendments, line-item transfers and revenue certification for FY 2020 Budget, and take any necessary action.

There were none.

Receive letter from Texas Commission on Jail Standards.

Andy Louderback, Sheriff, spoke to the Court regarding the Jackson County Jail inspection on January 14, 2020 and noted that it is in compliance with Texas Minimum Jail Standards.

A motion was made by Comm. Belicek, and seconded by Comm. Bubela to receive the letter from Texas Commission on Jail Standards and the Certification of Compliance. Motion carried.

Receive \$13,831.80 reimbursement check from Kinder Morgan for damages to road and fence in Precinct 1, and take any necessary action.

A motion was made by Comm. Hunt, and seconded by Comm. Bublea to receive a reimbursement check in the amount of \$13,831.80 from Kinder Morgan for damages to CR 117 and fence in Precinct 1. Motion carried.

Consider Contract for Professional Services for retainer with Allison, Bass & Magee, L.L.P. to assist with redistricting districts, and take any necessary action.

Judge Sklar informed the Court on the services and fees regarding retaining Allison, Bass & Magee, L.L.P. She explained that \$18,500.00 would be the max amount charged for services. The total would include a \$5,000.00 payment to determine the need for reapportionment, due in October 2021, and two more payments of \$6,750.00, beginning in October 2022 if required.

A motion was made by Judge Sklar, and seconded by Comm. Belicek to enter into an agreement with Allison, Bass & Magee, L.L.P. for redistricting services. Motion carried. Clerk's Note: A copy of the contract on file among exhibits of Commissioners' Court.

Update with the Jackson County Navigation District from Raymond Butler.

Raymond Butler, General Manager of the Jackson County Navigation District, updated the Court regarding easements on Navigation District property. He informed the Court that they are in the beginning stages of taking legal action against South Texas Electric Coop. who is refusing to pay for easements in the Jackson County Navigation District.
