### **Invocation and Pledge**

Comm. Hunt opened the meeting with prayer and Judge Sklar led the reciting of the Pledge of Allegiance of the United States of America.

#### Public Hearing on FY 2023 proposed Budget.

Public Hearing opened at 9:02 a.m. There were no public comments. Public Hearing closed at 9:03 a.m.

### Consider adoption of FY 2023 Budget, and take any necessary action.

### Consider approving Jackson County tax rate for 2022 tax year, and take any necessary action.

A motion was made by Judge Sklar, and seconded by Comm. Karl to adopt the Jackson County tax rate for 2022 in the total amount of .4158 of that, .3650 is County and .0508 is Flood which this budget will raise more total property taxes than last year's budget by \$965,902.00 (10.11%), and of that amount \$77,081.00 is tax revenue to be raised from new property added to the tax roll this year. Motion carried unanimously by a record vote.
