Project overtime, for the purposes of this grant, is defined as the time an employee on a twenty-eight (28) day cycle works on this project beyond one-hundred-sixty (160) hours of regular duty in the same time period. For employees on a seven-day (7) cycle, project overtime is defined as the time an employee works on this project beyond forty (40) hours of regular duty in the same time period. Paid leave shall be considered regular duty, though cannot work the program on the same day sick time is taken. Motion carried.

Consider acceptance of Lavaca-Navidad River Authority Community Development Partnership Program for Camp Mauritz Water Supply in the amount of \$18,892, certify and budget same, and take any necessary action

Judge Simons advised the Court that the Court received a letter, but the grant was never certified and budgeted.

A motion was made by Comm. Bubela, seconded by Comm. Belicek, to approve and accept the Lavaca-Navidad River Authority Community Development Partnership Program for Camp Mauritz Water Supply in the amount of \$18,892, and to approve the purchase of listed items. Motion carried.

Belicek, to approve the Proposed Agreed Order from Texas Commission on Environmental Quality in the amount of \$15,651.00, and to apply payment of fines to SEP if possible. Motion carried.
