At which time the following proceedings were had:

Invocation and Pledge

Comm. Hunt opened the meeting with prayer and Judge Sklar led the reciting of the Pledge of Allegiance of the United States of America.

Citizens Comments-Opportunity for the public to address Commissioners' Court on non-agenda items. The Court may not comment nor deliberate on non-agenda items. (Presentations should be limited to (5) minutes)

There were none.

Approval of Minutes and/or additions and corrections, if any.

The minutes from May 11, 2021 were submitted.

A motion was made by Comm. Bubela, seconded by Comm. Hunt, to approve the minutes. Motion carried.

Consider budget amendments, line-item transfers and revenue certification for FY 2021 Budget, and take any necessary action.

There were none.

Presentation from Michael Ada with Golden Crescent Regional Planning Commission on Economic Development and broadband opportunity, and take any necessary action.

Michael Ada with Golden Crescent Regional Planning Commission addressed the Court regarding Economic Development and broadband opportunity.

A motion was made by Judge Sklar, and seconded by Comm. Bubela to join the Economic Development study with the Golden Crescent Regional Planning Commission on economic development and to split the cost of \$5,000.00 with the City of Edna and the \$2,500.00 to come out of the Hotel/Motel tax. Motion carried.

Consider requesting Unclaimed Property Capital Credits for Counties under LGC Section 81.004, and take any necessary action.

A motion was made by Comm. Bubela, and seconded by Comm. Karl to request Unclaimed Property Capital Credits for Counties under LGC Section 81.004 and authorize the County Judge to sign. Motion carried.

Consider amendment to TDS contract, and take any necessary action.

A motion was made by Judge Sklar, and seconded by Comm. Bubela to table the amendment to the TDS contract. Motion carried.

Consider renovation of DPS Office within the Courthouse, and take any necessary action.

A motion was made by Comm. Martin, and seconded by Comm. Karl to approve the renovation to the DPS Office within the Courthouse in an amount up to \$5,000.00.

Consider future use of old Jail and Workforce Building, and take any necessary action.

A motion was made by Judge Sklar, and seconded by Comm. Martin to approve to move \$10,000.00, originally budgeted for the Workforce building, to start the clean up to the old Jail. Motion carried.

Consider bids for concrete overhang repair and column, and take any necessary action.

A motion was made by Comm. Martin, and seconded by Comm. Bubela to accept bid with BLS in the amount of \$26,900.00 for concrete overhang repair and column pending proof of liability insurance.


